



TERMS & AGREEMENTS

- Each participant is expected to cover the full cost of their trip. If the participant is a minor, it is expected that the parents, custodial parent or legal guardian who signs the consent form will assume responsibility to reimburse Reign Ministries all costs advertised or associated with the summer.
- Each participant is expected to obey all guidelines and follow the instructions of the leaders. A refusal to cooperate may result in the team member being sent home prematurely.
- Any additional expenses (individual's additional airfare fees, lodging, food, etc.), including those of the accompanying leader, incurred as a result of an individual having to return home prematurely for any reason (such as refusal to cooperate, health problems, death in family, etc.) will be the responsibility of the individual.
- If an individual cancels before or during Training Camp, the funds raised, *less* incurred expenses (penalties for airline, hotel, transportation and administrative fees), will remain credited to his/her account for one year.
- Each individual must submit a Royal Servants Physician Form (their physical), completed and signed. The form is in the Prep Packet folder.
- Each individual is responsible for personal medical costs. Each person must be covered by medical insurance the entire time they are with Royal Servants. If necessary, Royal Servants will pay for medical treatment while overseas with the understanding that the individual will reimburse Royal Servants. Royal Servants will submit the bills to the individual so that he or she can be reimbursed by his or her insurance company and then can reimburse Royal Servants. The individual is responsible to reimburse Royal Servants for all medical costs that their insurance may or may not cover. *If your current medical insurance does not cover you while you are overseas you might consider buying some travel insurance - you can contact Bursch Travel for more information - see Travel Consultant Form.*
- Participants will not be allowed to make the following changes to their bodies while with Royal Servants: tattooing, piercing, or any radical hair style change (i.e. coloring, Mohawk, etc.) How you come is how you go, and having piercings, etc., before the trip does not disqualify you.



RELEASE OF LIABILITY

I specifically release Royal Servants, and all concerned, from any claim of negligence in their duties as leaders, or otherwise on this mission trip. In the event that I would make a claim, I shall pay all legal fees and costs incurred by Royal Servants and other individuals and organizations involved.

I further hereby authorize the leadership of Royal Servants to make essential decisions on my behalf with respect to medical treatment, emergency surgery or hospitalization should such be necessary. However, Royal Servants shall in no way be responsible or liable for any medical bills incurred related to this mission trip. Should it be necessary for my son/daughter to return home due to disciplinary action, I assume the extra transportation costs.

I agree to whole-heartedly abide by all rules, regulations and guidelines set forth in the Royal Servants training materials (including Prep Packet and Parent Packet), and to abide by all decisions made by all leaders and those in authority.

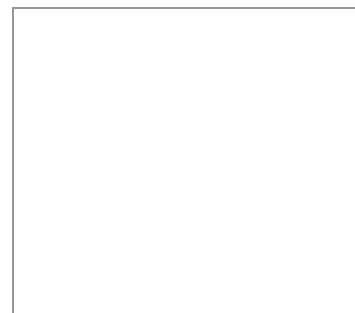
